Good evening [i_person|fname],

We hope you are doing well! According to our records you were scheduled to check in today, but it appears that you've not yet arrived at your residential community yet.

We wanted to follow-up to share that you may still check in **today**, as long as:

1. You are in compliance with symptom tracking,
2. You are in compliance with the COVID-19 Blackboard Training, **and**
3. You have access to the MarylandGenomics SampleScanner on your phone or smart device to test when you arrive.

You can check your compliance at umbc.edu/go/profile before you travel to campus to ensure you are in compliance. If you do not meet the criteria for checking in after hours, we encourage you to arrive on campus tomorrow between 9 a.m. or 4 p.m.

Even if you do not want to formally move-in during move-in weekend (Jan. 22 - Jan. 25) we are requesting that you at least come to your community to (1) complete your COVID-19 test and (2) activate your Campus ID Card. You are welcome to move your items in at a later date.

Out of an abundance of caution and to maintain public health standards at UMBC, we are unable to accommodate late arrivals. **If you are unable to come to campus before 4 p.m. on Jan. 25, 2021 to test and activate your ID, your housing assignment may be cancelled.**

If you believe you received this message by mistake and are already on campus, please go to your Community Desk to have then update your status.

If your housing plans have changed please complete an [RT Ticket \(https://reslife.umbc.edu/contact-us/\)](https://reslife.umbc.edu/contact-us/) as soon as possible, requesting to cancel your housing.

Due to public health measures and campus strategies to establish baseline COVID-19 status, Residential Life is not able to honor late arrival requests universally. Students may be permitted to move in after Jan. 25th only under granted exception.

Exception criteria includes: quarantine or medical at time of move-in, travel restriction or unforeseen travel issue, _____?

If granted, the following criteria must be met at time of check-in:

- Are in compliance with Symptom Tracking
- Are in compliance with the COVID-19 Blackboard Training, **and**
- Are in compliance with COVID Testing; a negative PCR test result within 3 days of scheduled arrival Rapid tests are not accepted.

Students will only be permitted to move-in on Friday or Monday by 3pm. This is to ensure sample goes out to lab at 5pm on day of arrival and results of test come in during weekday and can test on 4th day (Tuesday or Friday).

Upon arrival, student must complete self-swab and submit no later than 4pm. a

On 4th day after move-in, student must submit another sample for processing (Tuesday or Friday).
